Pacific Index Advisory offers safety of principal and a choice of Interest-Crediting Options to potentially grow your contract value.

Using hypothetical S&P 500[®] index returns of 6%, 2%, and -4%, the following examples compare two different Interest-Crediting Options available with the 7-year withdrawal charge on this product.

Point-to-Point Option (with Cap)

1-Year Index Term, S&P 500[®] Index

A positive index return is credited to your contract, up to the cap, at the end of the one-year index term.

Hypothetical Index Return	Interest Credited	Contract Value After 1 Year
6.00%	6.00%	\$106,000
2.00%	2.00%	\$102,000
-4.00%	0.00%	\$100,000 (no loss)

A cap is the maximum interest that can be earned if the return exceeds the cap. If the index return is flat or negative no interest is credited to the contract and there is no loss. The cap is set at contract issue and applies for the length of the index term.

Performance-Triggered Index Option

1-Year Index Term, S&P 500[®] Index

A declared interest rate is credited when triggered by a flat or positive index return over one contract year.

Declared Interest Rate

9.45%

Hypothetical Index Return	Interest Credited	Contract Value After 1 Year
6.00%	9.45%	\$109,450
2.00%	9.45%	\$109,450
-4.00%	0.00%	\$100,000 (no loss)

A flat or positive index return triggers the declared interest rate to be credited to the contract value. If the index return is negative, no interest is credited, but there will be no loss and the contract value will remain the same. The declared interest rate is set at contract issue and applies for the entire withdrawal charge period.

Interest credited assume a \$100,000 initial purchase payment, no withdrawals, and no optional benefits for a 7-year Withdrawal Charge Period.
